3. Prices to be quoted in Tanzanian Shillings (TZS)
4. Six Rivers Africa Destination including all charges related to freight, in-transit insurance and unloading the goods at Six Rivers Africa office. Title and risks remain with the Supplier until delivery to Six Rivers Africa office.
5. In the event of a discrepancy/error in the total prices that will be indicated on the above quote the unit price will prevail.
6. Terms of payment shall be Net 14 days from the receipt of Supplier's original invoice by Six Rivers Africa
7. Supplier's proposal shall be valid for Thirty (30) working days from the date of Supplier's submission.
